PETER M. LEHRER INDUCTED INTO NORTH CAROLINA STATE HALL OF FAME

NEW YORK – Nov. 6, 2018 – Peter M. Lehrer, who graduated with honors from North Carolina State University with a bachelor’s degree in Civil Engineering, was inducted into the University’s Department of Civil, Construction, and Environmental Engineering Hall of Fame last week based on his significant accomplishments in the construction industry. He was also awarded the Distinguished Engineering Alumnus Award, which honors engineering graduates who have been recognized for outstanding achievement.

Since graduating in 1963, Lehrer has dedicated his professional work as a construction manager, and now, as an advisor, managing largescale projects and providing strategic guidance to owners, developers, and institutions. With a focus on delivering solutions to multifaceted projects, Lehrer has spent more than 50 years helping clients navigate a myriad of construction complexities all while focusing on reducing costs and improving program-wide efficiencies.

As Chief Executive Officer of all U.S.-based Bovis Ltd. subsidiary companies, Lehrer was responsible for managing a staff of 2,000 that completed billions of dollars of work annually. He then founded Lehrer, LLC in 1996, a successful New York-based construction advisory firm, which became Lehrer Cumming, a division of international construction consultancy Cumming, earlier in 2018.
